H) The first party will offer 15% discount to the patient on preadmission investigation OP Charges. (Not applicable to insurance cases)

I) First party will impart EMS training to employees/students of the second party.

J) First party will conduct lectures on health awareness to the employees/ Students of the second party once in a year as per date of mutual convenience.
