Immediate action is required as further action depends on this implementation. Regarding the action to be taken in pursuance of the proposed proposal, the committee members, please the following items should be considered.

1. Mention provisions in section 37 (1)(N) and (T) of Educational Audit Report colleges have to prove necessary details as per audit report and then committee should submit their report.
2. Committee should verify that subjects/courses to be thought in the college since it's inception and whether there is approval for faculty/departments by Government and University or not. Verifying all the facts information should be mention in the report.
3. If the examination centre has been approved by the university for the concerned college, the committee shall directly inspect whether the necessary facilities have been provided by the college or not, and the records and Observations should also be recorded in the report.
4. B.Ed/ M.Ed colleges have to finalise the admission capacity of the college as per approval of NCTE Bhopal, The committee should inspect and submit the report in accordance with the finalization of the admission capacity.

5. In which colleges M.B.A. syllabus is conducting, checking the M.B.A. syllabus accreditation by Apex Body (AICTE), and the report should be submitted after examining the admitted students as well as attending students.
6. The suggestions mentioned in the report by the committee are reviewed and approved by the principal of the college and the committee members.
7. If the chairman or members of the committee are unable to work on the said committee, the concerned should immediately inform the university office about this through a reasoned letter/e-mail. According to this new member or chairman will be nominated.

Taking the above matters into consideration, the Committee Chairman is again requested to visit the concerned colleges on the dates fixed and send the report immediately to University for co-operation.
